The following information from the Registry of the International Court of Justice has been communicated to the Press.

The International Court of Justice will meet on Monday, September 23rd, 1957 at 4 p.m. in the Peace Palace at The Hague.

The sitting will be the first in the oral hearings in the case of the Right of Passage over Indian Territory brought before the Court on December 22nd, 1955 by Application of the Government of the Portuguese Republic against the Republic of India.

On April 15th, 1957 a document setting out certain Preliminary Objections to the jurisdiction of the Court was filed by the Government of India. The Observations and Submissions of the Portuguese Government in regard to these Objections were filed on August 15th, 1957 and the case has since then, been ready for hearing.

During the coming hearings, the Court will deal with the Preliminary Objections.

The sitting will be devoted first to the installation of the Hon. Mahomed Ali Currim Chagla, Chief Justice of Bombay, and of Dr. Manuel Fernandes, former Director-General of the Ministry of Justice and member of the section for International Relations of the "Câmara Corporativa" (Upper House), who, in accordance with Article 31 of the Statute of the Court, have been designated by the Government of India and the Government of Portugal, respectively, to sit as judges ad hoc in this case.
