Continental Shelf (Tunisia/Libyan Arab Jamahiriya) (Request by Malta for permission to intervene) Closure of oral proceedings

The following information is made available to the press by the Registry of the International Court of Justice:

At public sittings held on 19, 20, 21 and 23 March 1981 the Court heard oral argument in the Continental Shelf case between Tunisia and the Libyan Arab Jamahiriya on the application submitted by the Government of Malta for permission to intervene in the case under Article 62 of the Statute.
