Dear Mr. Miller,

I have been reliably informed that *Ultima Hora* on February 3, 1950, and *El Comercio* on February 9, 1950, both of Lima, published what were alleged to be letters dated May 27 and August 30, 1949, from Mr. Garland Williams, the Narcotics Supervisor of the New York District, to Mr. N. J. Anslinger, the U.S. Commissioner of Narcotics. These letters contained statements that Edmundo Haya de la Torre was "closely associated" with the Peruvian cocaine traffic and implications that Víctor Raúl Haya de la Torre was likewise involved. I note certain obvious inaccuracies in the letters. For example, Víctor Raúl Haya de la Torre did not "visit the United States aboard an unidentified Peruvian battleship", but arrived and departed by Pan American World Airways and Peruvian International Airways, as can easily be verified.

With respect to the contents of the letters therefore, they clearly contain both inaccurate and unverified statements. Apart from those Peruvians referred to in the letters who have been tried and convicted in the United States courts, the letters in turn unfairly and inaccurately impugn the reputation of prominent Peruvians, with whom the American Federation of Labor has had pleasant

and helpful relations over a number of years.

In order that the reputation of eminent Peruvian friends of the American Federation of Labor may not be unjustly impaired by the publication of the letters referred to above, I would like to know if my understanding of the letters, as expressed above, is substantially correct.
